Pierpaolo Marano is a tenured Professor of Commercial Law at the Department of Legal Studies of the Catholic University of the Sacred Heart - Milan, and the University of Latvia. He is a Visiting Professor at the Southwest University of Political Science and Law, a scholar in residence at the University of Connecticut, School of Law – Insurance Law Center, an Honorary Fellow at the Asian Institute of International Financial Law of the University of Hong Kong, and an Affiliate Professor with the Department of Insurance at the University of Malta. Pierpaolo currently teaches Insurance Law and Regulation and European Union Risk Governance Regulation. He was teaching Commercial Law from 1997 to 2015 and European Union Insurance Law from 2015 to 2017. Graduated in Law at the Catholic University, Professor Marano holds a PhD in Banking Law and Regulation from the University of Siena.

Pierpaolo has been a visiting professor or a visiting lecture at the Katholieke Universiteit Leuven, National Taiwan University, University of Malta, Kozminski University (Warsaw), The Chinese University of Hong Kong - CFRED, University of Vilnius, Gujarat National Law University, Japanese Institute of Life Insurance, University of International Business and Economics (Beijing), Universidad Autonoma de Madrid, Universidade Nova de Lisboa, University of Exeter, University of Hong Kong - AIIFL, Universiti Selangor (Malaysia), Warsaw School of Economics, Pontificia Universidad Catolica de Chile, Universidad de Montevideo, CEVRO Institute (Prague).

A widely-sought writer and speaker on insurance law and regulation, he is one of the drafters of the Italian Code of Private Insurance as well as the Italian Corporate Law. Pierpaolo Marano has been appointed as an academic member of the Insurance and Reinsurance Stakeholders Group by the EIOPA (European Insurance and Occupational Pensions Authority) since September 2018, while he has already been a member of that stakeholder's group in 2012/13, and the Occupational Pensions Stakeholders Group in 2013/2016.

Appointed by the IVASS (Italian Insurance Supervisory Authority) as a member of the Disciplinary Guarantee Committee since December 2014, he is the Chairman of the Working Party on the Distribution of insurance products at the International Insurance Law Association (AIDA), since October 2014. He currently sits on the Presidential Council of AIDA and the executive board of AIDA — Europe. He is also the President of the Scientific Committee at AIDA Europe, and he is member of the academic committee of the Institut for European Traffic Law.

He is the Director of the AIDA Europe Research Series on Insurance Law and Regulation, which is published by Springer. He is serving as an associate editor of the *European Insurance law Review*, the review *Assicurazioni*, the *International Journal of Finance*, *Insurance and Risk Management*, the *Journal of Accounting*, *Finance and Auditing Studies* and he served as an associate editor of the *Journal of Insurance Issues* in 2012-2014.

Author of two monographs in Italian language, co-editor of three books in Italian language and six books in the English language, he has published more than one hundred academic papers in Italian, English and Spanish language.
